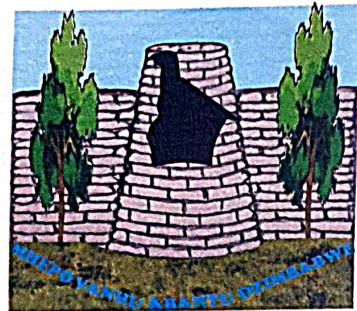

SUBJECT: SELECTION OF NEW ZIMBABWE PARLIAMENT, GOVERNMENT AND COUNCILS

Reference 1: Doc No. 01 - ZSC - Political Parties Ltr dated 15 August 2025

In accordance with Sections 32, 33 and 34 of the attached new apolitical Constitution of Zimbabwe signed at Mabweadziva / Njelele on 12 September 2024 by the full quorum Zimbabwe Spirit Council, you are hereby instructed by your fathers to form the new Parliament of Zimbabwe peacefully and expertly in conformity with parliamentary quotas allocated for each portfolio committee on the basis of skill/expertise and not politics shall you rebuild the Great Zimbabwe to extraordinary / unprecedented greatness and compete with America, Europe and Asia in every sphere of human development and own the African market by 100%. The new Constitution comes with futuristic technologies built on the moral foundation of the good old days - Chinyakare. Be advised that the market is now the new oxygen and whoever gives away their market will not survive but suffocate to extinction. When your fathers built the Great Zimbabwe among other African technologies, Europeans were eating uncooked dogs (hot dogs) due to technology limitations and so look up to your founders for inspiration to innovate noting that technology, industrialization or development are the hallmarks of diplomacy and without any talk, industrialization or development will speak very visibly at international level.

The new Constitution of Zimbabwe repeals the old Zimbabwe Constitution Amendment No.20 Act 2013 and subsequent amendments emanating from the Lancaster House Agreement, which primarily was Roman/English/Dutch law or the law of Imperialism upon whose altar African innovation, traditions, history and value system were sacrificed. Roman/English/Dutch law was crafted to subjugate other nations and on that basis you cannot compete fairly or succeed within the confines of imperial law for the reason that most provisions therein protect the gains of imperialism and your fathers are duly freeing you from imperial bondage. In the new Constitution, power derives from the spirits and people of Zimbabwe and is vested in YOU, the **experts or top skilled** citizens among the people through parliament, councils and government in order to **solve people problems**. Further, be reminded that the land of Zimbabwe was founded for the exercise of Unhu/Umbuntu and if you cannot abide by that requirement, you are free to emigrate into exile and assimilate into foreign lands or alternatively, you can found your own land and practise your desires or whichever law thereon. And if you are genuinely our children, you will fall-in and abide by the law of your forbearers. Moreover, maTateguru are aware that various ethnic groups came to settle in Zimbabwe in search of livelihood which is proof of the fertility of the land, however Zimbabwe will be governed by its traditions and settlers shall not impose their traditions/polities of origin on the land.

Democracy is toxic, divisive, a source of conflict and subjective in which millions of lives were lost in the world while trying to implement it and above all, democracy is a quantitative and not qualitative selection process which churns-out leaders with no skills and no capacity to solve people problems. Moreover, democracy is now monetized, exclusive to the rich citizens, obsolete and administered at a cost to the State. The leadership selection process specified in the new Constitution is at no cost to the fiscus thereby availing the entire electoral budget for people development. The head of state is spirit with no ego, no greed, no malice and most importantly with no faculty for

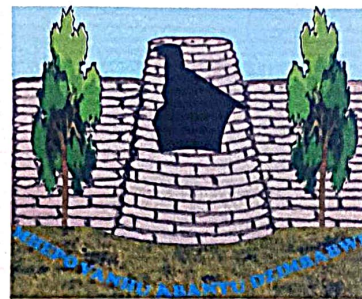

food consumption, which guided the people all the way from Guruuswa, *nokuti munhu haana chakanaka*. The President or Head of Government is selected by the Spirit Council from any willing citizen at no cost. Voting another person into office has no benefit to the voter and is unpaid work. Government ministers are selected through public interviews on merit while rural and urban councillors are selected from citizens skilled in rural and urban planning and not through political populism. The Great Zimbabwe was built by experts or citizens of high skills turnover. And being endowed with the most expert or skilled parliament in the world, government and councils selected by resume, the results will be unprecedented.

There is a State House for each member of the Zimbabwe Spirit Council with full facilities to host State events where ordinary people can visit without appointment in order to learn the traditions and history of the State. Imperial democracy being so defective and fraudulent, the object of the new Constitution is not to remove one leader in place of the other but to retire into the sewer system, the whole treacherous imperial project founded by the trio of Cecil Rhodes, Charles Rudd and Leander Starr Jameson at the end of 19th century. The new Constitution has no provision for elections in 2028 or any other time thereafter as democracy is a source of conflict, intolerant, violent and to that effect your fathers forbid the holding or participation in elections and all political parties are informed through referenced letter 1. The focus for citizens is now on State building under the leadership of spirit. Note how politicians are risking the life of followers in the dangerous democratic field for the reasons that campaign budgets are funded by Europe and the West, and politicians have serious protection from violence through personal bodyguards for fear of losing their life while ordinary citizens are at the mercy of political violence and intolerance inherent in democracy.

Section 51, Nhang/Gota of the new Constitution which outlaws premarital relationships and sex outside the marriage institution in accordance with Zimbabwe Traditions, is the silver bullet or panacea to all problems facing the State ranging from corruption, economic malaise, demise of the marriage institution, poor health and general moral decadence. Nhang/Gota provision is an adaptation to modern day spaces of school, work and entertainment in order to preserve Unhu/ubuntu. The current levels of moral decadence partly caused by the adoption of foreign value system are a threat to national security. Bulk of the current moral decadence was a consequence of the highly militarized and protracted liberation struggle which killed so many innocent life and introduced Vanhu/Abantu to mating outside the marriage institution which started with the abuse of war comfort girls (chimbwidos). War veterans will be paid their war time salaries, cleansed of war atrocities/blood guilt (ngozi) and disbanded thereafter. Citizens who died of war will be compensated and given proper burial while the comfort girls (chimbwidos) will be compensated for war time abuses.

All Zimbabwe communal and commercial farmlands belong to the State and cannot be sold which cancels out all 99 year leases and create the contract farming model by trained farmers for a profit and sponsored by the State to supply the local and international markets. The paper title deed undervalues Zimbabwe land, **title is on the basis of heritage, traceable by descent and all farm land title deeds issued are null and void.**

Section 56 assures freedom of worship, however spiritual leaders will be screened in order to protect the vulnerable followers from rogue men of cloth. Jails will be closed on the basis of Mhosva Inoripwa/Ubadalo Justice System for the state has no budget for the upkeep of criminals/murderers but invests generously in the welfare of victims of murder, orphans and widows. Alcohol is dispensed and indulged only in isolated enclosures in order to protect both drinkers and non-drinkers of alcohol. The settlement of avenging spirit / kuripa ngozi will be the responsibility of the State for failing to defend citizens from murder but the life of murderers and drug dealers/traffickers will not be spared. The travesty of Roman/English/Dutch law is the preoccupation with the rights of the murderer who is kept in five star amenities in jail on free wifi, food and accommodation while the survivors of murder, the orphaned children and widows languish in abject poverty.

Zimbabwe reverts to its original calendar with traditional holidays and a new year starting in mid September and celebrating Zimbabwe milestones and mythologies. It is a treasonable offence to make or trade in devices of witchcraft such as zvidhoma/umungcw, zvikwambo/tokoloshe, mativisi, zvitsinga and mheni/umbane among others which have the object of harming or killing other people noting that Europeans in the Middle Ages burnt witches on stakes in order to eradicate the scourge of witchcraft but when they invaded Africa, they claimed that witchcraft did not exist to ensure that Vanhu/Abantu exterminate each other. There is free health insurance called Mahara/Mahala Health Insurance for every citizen, free to air education system plus free justice delivery system to make life affordable for all. Zimbabwe is a gunless society where people are safer as a collective than if a few of them were licensed to own guns. The new Constitution being all inclusive, any persons or groupings that negate it are greedy, power hungry and not welcome by the founders to be part of Zimbabwe. Hinde!
