OKOCHA IKORO

We act on behalf of Mr Okocha Ikoro (**our client**).

PURPOSE

We are instructed to write to you regarding the false, misleading and seriously damaging allegations and imputations about our client, by Ms S Mutami (**Susan**) on your platform, alleging that our client, amongst others matters:

1. spiked her drink and/or drugged her;
2. sexually assaulted and/or raped her;
3. gave her a sexually transmitted infection (**STI**);
4. is dishonest, untruthful and guilty of a crime;
5. is involved in a criminal syndicate;
6. is involved in fraud;
7. is involved with drugs; and
8. is involved with trafficking young girls (**Wrongful Publications**).

Your platform has continued to publish the Wrongful Publications.

Our client's reputation has been seriously harmed and destroyed by the Wrongful Publications.

The Wrongful Publications have or would have significant devastation and serious harm to our client's reputation and livelihood.

DENIAL

At the outset, our client has instructed us that the Wrongful Publications are strongly denied, seriously damaging and harmful, untrue, false and misleading.

Susan has no basis, at law or under any statute or legislation to make the Wrongful Publications.

NOTICE

This letter is written notification to you that Susan acts are:

1. a form of harassment and bullying by her of our client; and
2. is in breach of the *Defamation Act 2005 (Qld) (Act)*.

We have written to Susan regarding her breach of the Act and on instructions are proceeding with legal proceedings accordingly.

CHRONOLOGY OF POSTS

We are instructed that the chronology of the Wrongful Publications, until 8 June 2026, are summaries as follows:

IDENTIFICATION OF CLIENT

All of your Wrongful Publications, include the following identification of our client:

1. directly naming him and spelling out his name;
2. uploading photographs of our client;
3. naming his place of work, and the suburb;
4. naming the Business our client owns and operates and the suburb his office is located;
5. naming the area he resides; and
6. tagging his social media account.

As a result of the Wrongful Publications, we are instructed that many individuals have:

1. shown up to and attended our client's place of residence;

2. contacted our client; and
3. contacted our client's immediate family.

POLICE COMPLAINT AND POLICE EMAIL

Susan made a complaint about our client to the Queensland Police Service (**Police**).

Her complaint against our client was investigated by Police, with no charges were laid against our client. In fact, there was no basis for Susan to make such a complaint.

As a result of the above, an email from Plain Clothes Constable, Olivia Beard, Brisbane City Criminal Investigation Branch of the Police dated 5 June 2026 (**Police Email**) was received on 5 June 2026.

In the Police Email (as defined above), Plain Clothes Constable, Olivia Beard of the Brisbane City Criminal Investigation Branch of the Police has written;

Good evening.

The investigation has been finalised and no further action will be taken by Police. As a result, your client's mobile phone that was seized will be returned to him, and is currently ready for collection at the Brisbane City Police Station front counter.

As I mention in my previous email, **Police do not have the power to force Susan to take down these social media posts.**

Should your client wish to make any criminal complaints in relation to Susan's actions, he can attend his local Police station and commence the complaint process there. Alternatively, **if you believe that these posts are defamatory in nature, there are civil routes that you can take** however police do not have involvement in this process.

(Emphasis and underlining added)

POSITION

We were instructed to write to you in relation to:

1. the Wrongful Publications being communicated by Susan using your platform; and
2. the false, misleading and seriously damaging nature of the Wrongful Publications that is currently on your platform about our client.

Your conduct in question amounts to very serious defamation of our client. The Wrongful Publications made by you are denied by our client and are clearly incorrect and untrue.

The meanings that are carried by the Wrongful Publications (**Defamatory Imputations**) that you are continuing to allow to be published to the world are that our client is, amongst other matters:

1. spiked her drink and/or drugged her;

2. sexually assaulted and/or raped her;
3. gave her a sexually transmitted infection (STI);
4. is dishonest, untruthful and guilty of a crime;
5. is involved in a criminal syndicate;
6. is involved in fraud;
7. is involved with drugs; and
8. is involved with trafficking young girls.

The Wrongful Publications expressly identify our client by name, and the Defamatory Imputations have been published.

As such, the spread of information is not limited to the people, to whom the statements were made, but to a wider audience on the internet.

We have been further instructed:

1. the Wrongful Publications and the Defamatory Imputations made by Susan have no basis in fact. In short, they are untrue, incorrect and denied;
2. the Wrongful Publications and the Defamatory Imputations are clearly false, misleading, deceptive and unreasonable; and
3. you have no basis, evidence or foundation to allow for the untrue, false, misleading, deceptive and unreasonable Wrongful Publications and Defamatory Imputations about our client to be continued to be seen on your platform.

REPUTATION

The Defamatory Imputations are defamatory because the Wrongful Publications are untrue.

As a result, our client's reputation has been seriously harmed and destroyed.

They are the genesis for serious harm suffered by our client, such that the Defamatory Imputations have had or would have significant devastation of our client's reputation and livelihood.

Given the above, it is reasonable to draw an inference that the publication of the Wrongful Publications were made either with an intent to cause serious harm, or with reckless indifference as to the significant damage it could cause to our client's reputation and livelihood.

As stated above, our client is a former president of his community, being the Nigeria Community. He is highly regarded and respected by members of his community, Australia wide. He is currently considered an elder person/leader of his community, who provides assistance, advice and guidance to members of his cultural community, Australia wide.

As a result of your conduct outlined in this letter in allowing for the continued publication, our client:

1. cannot show his face in his community or publicly;
2. is now required to step aside from his Business.

Further, the Wrongful Publications has caused serious harm to our client and poses a real risk of causing serious harm in the future.

DEMAND

Further, and having regard to our client's reputation, the Wrongful Publications made by you, and the publicity given to them, our client is entitled to compensation, loss and damage (**Damage**) from you. These rights and entitlements are reserved in all respects.

Given the above, we are instructed to write to you to demand:

1. that you immediately remove each and every Wrongful Publication, within seven (7) days of the date of this letter, and cease allowing the publishing of defamatory matters by Susan about our client;
2. provide us of evidence of your compliance with paragraph 1 above, within seven (7) days of the date of this letter; and
3. cease from reposting or sharing Susan's further untrue, false, misleading and seriously damaging allegations about our client in the future.

If you fail to adequately reply within seven (7) of the date to this letter, or if a reasonable resolution cannot be reached, our client reserves the right and entitlement to commence legal proceedings pursuant to the Act, without further notice to you.

Please note that if you do not immediately remove the Wrongful Publications on your platform and you allow for their continuing publication, our client will have no other option but to join you to the legal proceedings against Susan. In such proceedings are necessary, in addition to our client's entitlements under the Act and at law, our client shall also be seeking his costs from you.

RESERVATION OF RIGHTS AND FUTURE COMMUNICATION

Our client reserves all his rights in respect of this matter in all respects.

This letter shall be drawn to the attention of the appropriate Court (when required) in relation to the issue of costs.

Please ensure that all future communication in this matter is sent and addressed to our firm.

REPLY

We await your written reply within seven (7) days of the date of this letter.
